## 9.1 Discussion regarding entering into an agreement to become a member of the Heart of Illinois Special Recreation Association (HISRA)

Director Damery explained to everyone that HISRA is a cooperative extension of a municipal park district for the purpose to provide quality recreation programs and services to individuals with disabilities and special needs. Katie Hogan, Director of HISRA was in attendance and discussed the programs and services they provide to member districts. The reason it is coming up in discussions now is because we need to levy for this so we can join.

#### 9.2 Discussion of the 2007 Tax Levy Ordinance for the 2008-2009 Fiscal Year

Director Damery discussed the tax levy which a copy of had been provided in Commissioners packets for review. His recommendation was option no. 2 provided we join HISRA. As a result of an increase of more that 5% of the aggregate levy we would be required to hold a public hearing prior to our regular meeting on December 17, 2007 pursuant to the Truth in Taxation act.

# 9.3 Action on Resolution calling for a public hearing concerning the intent of the Washington Park District to sell Limited Tax General Obligation Bonds not to exceed \$370,000.

The public hearing is required to issue general obligation bonds that we need to pay the alternate revenue bond as part of the Bond Issue Notification Act.

Director Damery stated he felt the bid we received was appropriate. This company tremendously outbid the other gentleman and he is from Washington. To remove the asbestos from the classroom upstairs where we anticipate putting offices and the office next door we received a bid of \$4,400.
